A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES TO BECOME PORTIONS OF THE ALLEYS ADJACENT TO MUNICIPAL PARKING LOT NO. 10.

WHEREAS a strip or parcel of land now included within Municipal Parking Lot No. 10 is necessary for the widening of adjacent alleys to a 20-foot width in conjunction with the rehabilitation of said parking lot;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the following-described strip or parcel of land owned by the City of Riverside, being a portion of Municipal Parking Lot No. 10, be and is hereby dedicated by the City of Riverside and accepted for the public use for street purposes to become a portion of the alleys adjacent to said Municipal Parking Lot No. 10:

All that portion of Lots 1 and 2 in Block 26 of Village of Arlington, as shown by map filed in Book 1, Page 62 of Maps, records of San Bernardino County, California, more particularly described as follows:

BEGINNING at the most northerly corner of Lot 6 of Assessor's Map No. 53, as shown by map on file in Book 2, Page 12 of Assessor's Maps, records of Riverside County, California;

THENCE South 56° 00' 30" West, along the north-westerly line of said Lot 6 a distance of 196 feet to the most westerly corner of said Lot 6;

THENCE South 34° 00' 10" East, along the southwesterly line of said Lot 6 a distance of 1 foot to a line which is parallel with and distant 1 foot southeasterly as measured at right angle from said northwesterly line;

THENCE North 56° 00' 30" East, along said parallel line 170.01 feet to the beginning of a tangent curve with a radius of 25.00 feet and concaving southerly;

THENCE Northeasterly, Easterly and Southeasterly along said curve an arc length of 39.27 feet, thru a central angle of 89° 59' 20" to a line which is parallel with and distant 1 foot southwesterly as measured at right angle from the northeasterly line of said Lot 6;
