All that portion of Gage Street (formerly Norton Street) of Tract No. 4 of the Riverview Addition to the City of Riverside, as shown by map on file in Book 7, Page 6 of Maps, records of Riverside County, California, lying west of the westerly line of that portion of Gage Street as vacated by the City Council of the City of Riverside by Resolution No. 10644, recorded September 22, 1966, as Instrument No. 94559 of Official Records of said Riverside County;

be changed to ED PERKIC STREET.
