

GRANT DEED

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Lot 3 in Block 68 of Tract No. 2 of La Sierra Heights, as shown by map on file in Book 7, Page 66 of Maps, records of said Riverside County, more particularly described as follows:

BEGINNING at the most easterly corner of that certain parcel of land conveyed to Theodore R. Springer, et ux., by deed recorded December 4, 1963, as Instrument No. 127330 of Official Records of said Riverside County; said corner being also in the northeasterly line of said Lot 3;

THENCE North 19° 04' 27" West, along said northeasterly line 120 feet to the most easterly corner of that certain parcel of land conveyed to Harlan E. Hardison, et ux., by deed recorded August 16, 1974, as Instrument No. 105371 of Official Records of said Riverside County;

THENCE South 66° 28' 43" West, along the southeasterly line of said parcel so conveyed to Harlan E. Hardison, et ux., 10.03 feet to a line which is parallel with and distant 10.00 feet southwesterly, as measured at right angle, from said northeasterly line of Lot 3;

THENCE South 19° 04' 27" East, along said parallel line 119.99 feet, more or less to the southeasterly line of said parcel of land so conveyed to Theodore R. Springer, et ux.;

THENCE North 66° 31' 43" East, along said southeasterly line 10.03 feet to the point of beginning.
