A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NOS. 4603-1, 9037-2 AND 9037-1 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 19330) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF COMANCHE AVENUE, SEMINOLE PASSAGE AND SHOSHONE AVENUE, RESPECTIVELY.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Comanche Avenue, Seminole Passage and Shoshone Avenue, respectively:

Parcel 1

Lot "I" of Tract No. 4601-3 in the City of Riverside, County of Riverside, State of California, as shown on map filed in Book 76, Pages 1 and 2 inclusive of Maps, in the office of the County Recorder of said County.

Parcel 2

Lot "C" of Tract No. 9037-2 in the City of Riverside, County of Riverside, State of California, as shown on map filed in Book 121, Pages 77 to 80 inclusive of Maps, in the office of the County Recorder of said County.

Parcel 3

Lot "E" of Tract No. 9037-1 in the City of Riverside, County of Riverside, State of California, as shown on map filed in Book 121, Pages 73 to 76 inclusive of Maps, in the office of the County Recorder of said County.
