

EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, A.S.D., a California limited partnership as Grantor, grants to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of drainage facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 1 in Block 38, also a portion of Iris Street (vacated) of the Alessandro Tract, as shown by map on file in Book 6 of Maps, at Page 13 thereof, records of San Bernardino County, California, described as follows:

BEGINNING at the most easterly corner of Lot "B" of Tract 22551, as shown by map on file in Book 127 of Maps, at Pages 62 through 66, thereof, records of Riverside County, California, said corner being on the centerline of said Iris Street, also being the southerly line of Section 21, Township 3 South, Range 4 West, S.B.M.;

THENCE North 89° 34' 43" East, along said line, a distance of 86.42 feet;

THENCE northwesterly on a non-tangent curve concave southwesterly, having a radius of 3094.00 feet through an angle of 04° 10' 30", an arc length of 225.45 feet to a point of Reverse Curvature (the initial radial line bears North 13° 44' 19'' East);

THENCE northwesterly on a curve concave northeasterly, having a radius of 170.00 feet through an angle of 05° 24' 57", an arc length of 16.07 feet to the easterly line of Lot "A" of said Tract 22551 (the initial radial line bears South 09° 33' 49" West);

THENCE South 08° 12' 40" West, a distance of 7.51 feet;

THENCE southeasterly on a non-tangent curve concave northeasterly, having a radius of 39.50 feet through an angle of 31° 22' 51", an arc length of 21.63 feet (the initial radial line bears South 63° 34' 32" West);

THENCE southeasterly on a non-tangent curve concave southwesterly, having a radius of 3074.00 feet through an angle of 02° 35' 46", an arc length of 139.29 feet to the POINT OF BEGINNING (the initial radial line bears North 09° 34' 49" East);

The preceding three (3) courses being along the easterly line of said Lot "A" and the northerly line of said Lot "B".

TOGETHER WITH the right to clear and keep clear said easement and right-of-way from any structures or trees, to enter upon and to pass and repass over and along said property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees, whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said drainage facilities.
