A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING LOTS "I" AND "J" OFFERED FOR DEDICATION FOR CONSTRUCTION AND MAINTENANCE OF STORM DRAIN FACILIITIES BY THE MAP FOR TRACT NO. 5751.

WHEREAS in connection with the final map for Tract (27)
No. 5751, Lots "I" and "J" thereof were offered for dedication
for construction and maintenance of storm drain facilities; and

WHEREAS on May 17, 1977, the City Council of the City of Riverside adopted its Resolution No. 13104 accepting the final map of Tract No. 5751; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: Lots "I" and "J" of Tract No. 5751 as shown by map on file in Book 90 of Maps, at pages 41 and 42 thereof, records of Riverside County, California, and offered for

dedication thereby for the construction and maintenance of storm drain facilities is hereby accepted as a public storm drain easement together with all rights to construct and maintain therein storm drains and appurtenant facilities and for uses incidental thereto.

Section 2: The City Clerk of the City of Riverside is hereby authorized and directed to cause a certified copy of this resolution to be recorded in the Office of the County Recorder of Riverside County, California.


