

## GRANT DEED

MELCHOR R. HUERTA, JR., and PATRICIA V. HUERTA, husband and wife as joint tenants, Grantors, FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do hereby grant to the CITY OF RIVERSIDE, a municipal corporation, the real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lots 45 and 47 of map of Division "C" of Hall's Addition to Riverside; on file in Book 9, Page 3 of Maps, records of San Bernardino County, California, described as follows:

BEGINNING at a point in the northeasterly line of said Lot 45, distant thereon 136.00 feet southeasterly of the easterly line of Park Avenue, as shown by said map; said point also being in the easterly line of that certain parcel of land conveyed to the Riverside County Mutual Building & Loan Association by deed recorded December 9, 1930, in Book 880, Page 493 of Deeds, records of Riverside County, California;


