A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 17952; RESERVING PERMANENT EASEMENTS AND RIGHTS OF WAY FOR ELECTRIC ENERGY DISTRIBUTION FACILITIES AND UNDERGROUND TELEPHONE, TELEGRAPH AND COMMUNICATION FACILITIES AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE RESERVATION OF SUCH EASEMENTS; AND MAKING ITS ORDER VACATING A PORTION OF HORACE STREET (SOUTHWESTERLY SIDE) AND A PORTION OF MAUDE STREET (NORTHEASTERLY SIDE), NORTHWESTERLY OF LINCOLN AVENUE.

WHEREAS on March 17, 1992, the City Council of the City of Riverside adopted Resolution No. 17952 declaring its intention to order the vacation of a portion of Horace Street (southwesterly side) approximately 7 feet wide by 187 feet long, and to vacate a portion of Maude Street (northeasterly side) approximately 7 feet wide by 186 feet long, northwesterly of Lincoln Avenue, and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Public Streets, Highways, and Service Easements Vacation Law, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and found and hereby finds from all of the

evidence submitted that the portions of Horace Street and Maude Street ordered vacated are unnecessary for present or prospective public use;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the portions of Horace Street and Maude Street in the City of Riverside, County of Riverside, State of California, described in the document attached hereto, marked Exhibit A, and by this reference made a part hereof, be and the same are hereby vacated.

BE IT FURTHER RESOLVED that the City Council does hereby determine that the public convenience and necessity require the reservation of permanent easements and rights of way for electrical energy distribution facilities, and reserving the right to construct, maintain, operate, replace, remove, renew and enlarge lines of pipe, conduits, cables, wires, poles and other convenient structures, equipment and fixtures, as may be applicable, for the transportation or distribution of electrical energy; and a permanent easement and right of way to construct, place, operate, inspect, maintain, repair, replace and remove such aerial and underground telephone, telegraph and communication structures as the Pacific Telephone and Telegraph Company may from time to time require consisting of poles, anchors, wires, cables, conduits, manholes, markers and necessary fixtures and appurtenances; including access and the right to keep the property free from inflammable materials and wood growth that would interfere with the use of said permanent easements and rights of way.

BE IT FURTHER RESOLVED that the vacation shall occur only after the applicable conditions contained in the Planning Department's report to the legislative body and on file with the City Clerk have been satisfied; and the City Clerk is hereby directed not to record this resolution of vacation until the applicable conditions have been satisfied.

ALSO RESERVING THEREFROM a permanent easement and right of way for aerial and underground telephone, telegraph, and communication facilities.



PARCEL 1


