A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR AN EASEMENT FOR STORM DRAIN PURPOSES.

BE IT RESOLVED, by the City Council of the City of Riverside, California, that the hereinafter described strip or parcel of land owned by the City of Riverside, in the area generally known as "Sycamore Canyon Business Park" be and is hereby dedicated by the City of Riverside and accepted for public use as an easement for storm drain purposes. Said parcel or strip of land is located on the Easterly side of Sycamore Canyon Boulevard northerly of Eastridge Avenue in the City of Riverside, County of Riverside, State of California, and is described in the attached legal description marked Exhibit "A" and the attached plat marked Exhibit "B", both of which are made a part hereof by this reference.

BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to cause a certified copy of the resolution to be recorded in the office of the County Recorder of Riverside County, California.

EXHIBIT "A"

That portion of Parcel 6 of Parcel Map No. 24733, as shown by map on file in Book 175 at pages 30 through 36 inclusive thereof, Records of Riverside County, California, described as follows:

Beginning at the most southerly corner of said Parcel 6;

Thence North 51° 01' 18" East along the southeasterly line of said Parcel 6, a distance of 166.18 feet to the southeast corner thereof;

Thence North 00° 33' 20" West along the east line of said Parcel 6, a distance of 82.97 feet to a point thereon;

Thence South 51° 01' 18" West, a distance of 143.55 feet;

Thence South 71° 00' 54" West, a distance of 67.27 feet to a point on the southwesterly line of said Parcel 6, said point being on a non-tangent curve, concave to the southwest, having a radius of 1005.40 feet, the radial line from said point bears South 55° 36' 17" West;

Thence southeasterly along said southwesterly line and along said curve, to the right, through a central angle of 05° 03' 20", an arc distance of 88.71 feet to the true point of beginning, the radial line from said point bears South 60° 39' 36" West.

Containing 0.30 acres, more or less.


