RESOLUTION NO. 19987

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE. CALIFORNIA, PROVIDING FOR THE SUMMARY VACATION OF OFFERS OF DEDICATION FOR FORMERLY PLANNED EAGLE RIDGE DRIVE.

WHEREAS, the City of Riverside proposes to vacate offers of dedication for street, sidewalks, and attending purposes along a portion of proposed Eagle Ridge Drive situated southerly of Eastridge Street, northerly of Cottonwood Avenue, and easterly of Sycamore Canyon Boulevard, as described and depicted in Exhibits "A" and "B," attached hereto and incorporated by reference (hereinafter "the Property"); and

WHEREAS, the Property is excess right-of-way not required for street or highway purposes; and

WHEREAS, the adjoining properties and public service easements will not be affected by the vacation of the Property; and

WHEREAS, the Property has been closed and impassable as a public street and no public funds have been expended on its maintenance for the last five years; and

WHEREAS, Section 8331 of the Streets and Highways Code provides that the legislative body of a local agency may summarily vacate a street if it has been impassable for vehicular travel and no public money was expended for its maintenance for a period of five consecutive years; and

WHEREAS, Section 8334 of the Streets and Highways Code provides that the legislative body of a local agency may summarily vacate the excess right-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, the City Council wishes to proceed under the provisions of Section 8330, et seq. of the Street and Highways Code to summarily vacate the described Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: The vacation of the described Property is undertaken pursuant to the provisions of Chapter 4 (commencing with Section 8330) of Part 3 of the Streets and Highways Code of the State of California.

City Attorney's Office

Section 2: The City Council finds and determines as follows:

- a. The described Property is excess right-of-way and is not required for street purposes.
- b. The vacation of the Property will not cut off all access of any parcel of property and will not affect any public service easement.
- c. The Property has been closed and impassable as a public street and no public funds have been expended on its maintenance for the last five years

Section 3: The proposed summary street vacation project is exempt from the provisions of the California Environmental Quality Act pursuant to Section 15061 (b) (3) of the Guidelines for Implementation of the California Environmental Quality Act (Title 15, California Code of Regulations, commencing with Section 15000) as it can be seen with certainty that there is no possibility that the activity will have a significant effect on the environment.

Section 4: The City Council hereby orders the summary vacation of the offer of dedication recorded as instrument number 447027 in the Official Records of Riverside County, California, also known as City deed number 14045, a copy of which is attached hereto as Exhibit "A," and incorporated herein by this reference.

Section 5: The City Council hereby orders the summary vacation of the offer of dedication recorded as instrument number 462741 in the Official Records of Riverside County, California, also known as City deed number 14048, a copy of which is attached hereto as Exhibit "B," and incorporated herein by this reference.

Section 6: The public convenience and necessity requires the exception from the vacation hereinabove ordered of an easement and right-of-way for public utility purposes as described in the easement recorded as instrument number 241457 in the Official Records of Riverside County, California, also known as City deed number 13705, a copy of which is attached hereto as Exhibit "C," and incorporated herein by this reference.

Section 7: The City Clerk of the City of Riverside shall assign a deed number hereto and cause a certified copy of this resolution to be recorded in the Office of the County Recorder of Riverside County, California, and the offers of dedication described in Exhibits "A" and "B" shall

be and are hereby terminated as of the date of said recordation and shall no longer constitute offers of dedication for a public street or right-of-way and attending purposes from and after said date of recordation.





FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, EDGEMONT COMMUNITY SERVICES DISTRICT, a political subdivision of the County of Riverside, as Grantor, grants to the CITY OF RIVERSIDE, a municipal corporation of the State of California, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of electrical energy distribution and transmission facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

Those portions of the Northwest Quarter of Section 10, Township 3 South, Range 4 West, San Bernardino Meridian, described as follows:



from or by reason of any use of the subject easement area by Grantor and their agents, assigns and successors.


