

Grant of Easement for Public Street Purposes

That certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 1 in Block 41 of La Granada, as shown by map on file in Book 12, Pages 42 through 51 of Maps, records of Riverside County, California, described as follows:

COMMENCING at a point on the northerly line of said Lot 1, distant 50 feet westerly from the northeasterly corner of said Lot;

THENCE southerly and parallel with the easterly line of said Lot 1, a distance of 5.00 feet to the southeasterly corner of that certain parcel of land described in Grant Deed to the County of Riverside by document recorded April 6, 1955, as Instrument No. 22342 of Official Records of said Riverside County, and the POINT OF BEGINNING of the parcel of land being described;

THENCE continuing southerly and parallel with said easterly line of Lot 1, a distance of 5.00 feet to a line that is parallel with and distant 40.00 feet southerly, as measured at right angles, from the centerline of Arlington Avenue as shown by said map;

THENCE westerly along said parallel line, a distance of 50.00 feet to easterly line of that certain parcel of land described in deed to Fred A. Harris, et ux., by deed recorded June 7, 1946, in book 755, Page 160 of Official Records of Riverside County, California;

THENCE northerly along said easterly line, a distance of 5.00 feet to the southwesterly corner of said parcel of land described in deed to the County of Riverside;

THENCE easterly along the southerly line of said parcel of land described in deed to the County of Riverside, a distance of 50.00 feet to the POINT OF BEGINNING.

Area - 250 square feet.


