RESOLUTION NO. 23504

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA CHANGING THE STREET NAME OF A PORTION OF PROSPECT AVENUE, BETWEEN FIFTEENTH STREET AND SAUNDERS STREET, TO WOODIE WAY.

WHEREAS, California Government Code section 34091.1 provides that whenever the legislative body finds that a name should be adopted and applied to any street, or that the existing name of any city street should be changed, the legislative body may adopt a resolution designating a name for, or change the name of, such street; and

WHEREAS, the Office of the Mayor received a request from the NAACP Riverside Branch requesting a street name change of a portion of Prospect Avenue, between Fifteen Street and Saunders Street, to Woodie Way; and

WHEREAS, the naming would honor the late Waudieur Rucker-Hughes, who was an active member of multiple community commissions, served as president of the NAACP Riverside Branch, and dedicated her life to assisting homeless and foster students in the community; and

WHEREAS, on October 22, 2019, the City Council held a public hearing and after considering all of the testimony both written and oral, authorized the name change.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That portion of Prospect Avenue, between Fifteen Street and Saunders Street, as shown on the map in the attached Exhibit "A", and incorporated herein by reference, is hereby changed to Woodie Way.

Section 2: The City Clerk of the City of Riverside is hereby authorized and directed to cause a certified copy of the Resolution to be recorded in the office of the County Recorder of Riverside County, California.

<u>Section 3</u>: Pursuant to California Government Code section 34092, the City Clerk is further authorized and directed to promptly forward a copy of the Resolution for the street name change to the Board of Supervisors of Riverside County, California.


