A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR PUBLIC UTILITY PURPOSES LYING NORTHWESTERLY OF THE SOUTHEASTERLY LINE OF MERICKEL SUBDIVISION.

WHEREAS, it appears that the City of Riverside has an easement and right of way for public utility purposes lying northwesterly of the southeasterly line of Merickel Subdivision, as hereinafter described; and,

WHEREAS, it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for public utility purposes be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

That portion of that certain public utility easement as conveyed to the City of Riverside by deed recorded January 28, 1932, in Book 134, page 248 of Deeds, Records of Riverside County, California, lying northwesterly of the southeasterly line of Merickel Subdivision, as shown by map on file in Book 7, page 19 of Maps, Records of said Riverside County.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.


