

RESOLUTION NO. 9082

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING EASEMENTS AND RIGHTS OF WAY OVER AND ACROSS LOT "A" OF KNOLL TRACT.

WHEREAS, it appears that the City has permanent easements and rights of way over and across Lot "A" of Knoll Tract; and,

WHEREAS, it appears that said easements and rights of way are no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easements and rights of way be and the same are hereby vacated. The said easements and rights of way are situate in the City of Riverside, County of Riverside, State of California, and are described as follows:

Permanent easements and rights of way to construct, maintain, operate, replace, remove and renew sanitary sewers and storm drains and appurtenant structures in, upon, over and across Lot "A", also known as Knollwood Place, as shown on map of Knoll Tract on file in Book 25, page 96 of Maps, Records of Riverside County, California, excepting the southerly 11.00 feet thereof, and reserving the right to construct, maintain, operate, replace, remove, renew and enlarge lines of pipe, conduits, cables, wires, poles and other convenient structures, equipment and fixtures for the operation of gas pipe lines, telegraphic and telephone lines and for the transportation and distribution of electric energy, petroleum and its products, water and incidental purposes, including access, and the right to keep the property free from inflammable materials and wood growth and otherwise protect the same from all hazards in, upon and over said Lot "A".

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.




