RESOLUTION NO. 9196

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF CONDUIT STREET.

WHEREAS, on July 18, 1961, the City Council of the City of Riverside adopted Resolution No. 9179 declaring its intention to order the vacation of a portion of Conduit Street and fixing the time and place for hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Section 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS, said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside, and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and,

WHEREAS, on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds from all of the evidence submitted that the street hereinafter ordered vacated is unnecessary for present and prospective use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the portion of the street located in the City of Riverside, County of Riverside, State of California, and described as follows:

All that part of the existing Conduit Street, 40.0 feet in width, lying northwesterly of the westerly line of Golden Star Avenue in a part of the southwest quarter of Section 14, Township 3 South, Range 5 West, San. Bernardino Base and Meridian,

is unnecessary for present or prospective public use, and that the same be and is hereby vacated.


