

1 RESOLUTION NO. 9261

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY
3 OF RIVERSIDE, CALIFORNIA, ACCEPTING THE
4 DEDICATION OF A PORTION OF ALESSANDRO BOULEVARD
5 TO PUBLIC USE FOR STREET PURPOSES.

6 BE IT RESOLVED by the City Council of the City of River-
7 side:

8 That the herein described strip or parcel of land is
9 hereby accepted by the City of Riverside to the public use for
10 street purposes to become and to be known as a portion of
11 Alessandro Boulevard.

12 Said strip or parcel of land is located in the City of
13 Riverside, County of Riverside, State of California, and is
14 described as follows:

15 A strip of land 5.0 feet in width in a part of the
16 East one-half of the Southeast quarter of Section 1,
17 Township 3 South, Range 5 West, San Bernardino Base
18 and Meridian, described as follows:

19 Commencing at a point on the east line of said
20 Section 1, distant thereon South 00° 14' East a
21 distance of 20.0 feet from the northeast corner of
22 the Southeast quarter of the Southeast quarter;

23 Thence South 89° 51' 30" West, parallel with
24 and distant southerly 20.0 feet from, measured at
25 right angles to, the north line of said Southeast
26 quarter of the Southeast quarter, a distance of
27 531.20 feet, more or less, to an intersection with
28 the westerly line of that certain 100.0 foot wide
29 parcel of land conveyed to the City of Riverside by
30 deed recorded in Book 518 of Official Records of
31 Riverside County, California, at page 370 thereof,
32 for the true point of beginning: (said 100.0 foot
parcel of land is now known as Alessandro Road);

Thence South 19° 02' 00" East along the westerly
line of said Alessandro Road a distance of 84.55 feet
to a point;

Thence South 89° 51' 30" West a distance of 5.29
feet to a point on a line which is parallel with and
5.0 feet westerly from the westerly line of said
Alessandro Road;

Thence North 19° 02' 00" West along said parallel
line a distance of 243.04 feet to a point;

Thence North 89° 51' 30" East a distance of 5.29
feet to the westerly line of said Alessandro Road;

Thence South 19° 02' 00" East, a distance of
158.54 feet to the true point of beginning.
