

RESOLUTION NO. 9396

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A SEWER EASEMENT IN PORTIONS OF SECTIONS 20 AND 29, TOWNSHIP 2 SOUTH, RANGE 4 WEST, S.B.B. & M.

WHEREAS, it appears that the City has a sewer easement over and across portions of Sections 20 and 29, Township 2 South, Range 4 West, San Bernardino Base and Meridian; and

WHEREAS, it appears that said easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

A strip of land 10.0 feet in width in a part of the South-half of Section 20 and the North-half of Section 29, Township 2 South, Range 4 West, San Bernardino Base and Meridian, the center line of said strip being described as follows:

Commencing at a point in the center line of Valencia Drive 50.0 feet in width, which said point bears North $0^{\circ} 07' 30''$ West a distance of 3.90 feet from the intersection of the center line of said Valencia Drive and the center line of Big Springs Road 100.0 feet in width as shown on the map of University Hills Unit No. 1 on file in Book 34, pages 71 and 72 of Maps, Records of Riverside County, California;

Thence South $77^{\circ} 27' 45''$ West along said center line a distance of 752.32 feet to the true point of beginning of this center line description:

Thence continuing South $77^{\circ} 27' 45''$ West 405.0 feet to a point which is designated as Coordinate Station 18 plus 79.07 North and 14 plus 51.90 East according to an existing system of Coordinates of the University of California at Riverside;

Thence South $82^{\circ} 38' 10''$ West a distance of 415.0 feet to a point designated as Coordinate Station 18 plus 23.84 North and 10 plus 40.59 East of said University of California Coordinate System;

Thence North $69^{\circ} 18' 30''$ West a distance of 835.0 feet to an end at designated Coordinate Station 21 plus 15.00 North and 2 plus 58.00 East of the said University of California at Riverside Coordinate System.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution

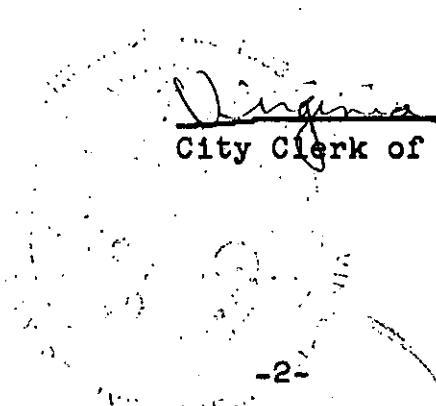

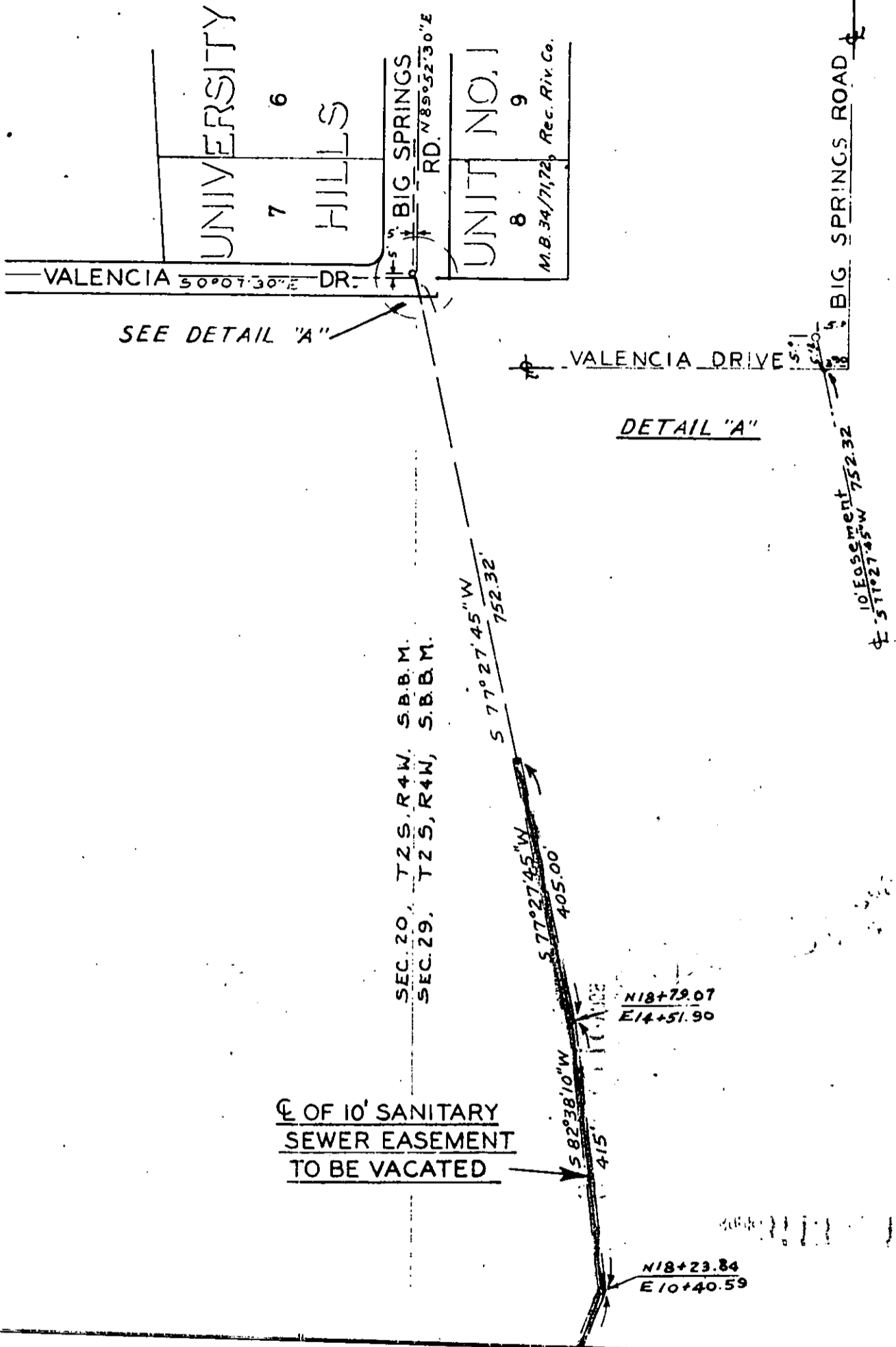
