A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS, the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the names of the herein-after designated streets be changed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

BAKER STREET

All that certain street now known as Baker Street as shown on a map of Mc Claskey Tract on file in Book 10, pages 36 and 37 of Maps, Records of Riverside County, California,

be changed to PAYTON AVENUE.

MARIPOSA STREET

All that certain street now known as Mariposa Street as shown on a map of El Ultimo Tract on file in Book 16, page 27 of Maps, Records of Riverside County, California;

EXCEPT those portions previously vacated, be changed to BERMUDA AVENUE.
