RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING A PORTION OF LOT 14, BLOCK 7 OF THE LANDS OF THE RIVERSIDE LAND AND IRRIGATING COMPANY TO PUBLIC USE FOR STREET PURPOSES, AND NAMING A PORTION OF SAID LOT 14, BLOCK 7, AS A PORTION OF SHELBY DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described strip or parcel of land is hereby dedicated by the City of Riverside to the public use for street purposes to become and to be known as a portion of SHELBY DRIVE.

Said strip or parcel of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

> That portion of Lot 14, Block 7 of the Lands of the Riverside Land and Irrigating Company, as shown on map on file in Book 1, page 70 of Maps, Records of San Bernardino County, California, described as follows:

> Commencing at the southwesterly corner of said Lot 14;

Thence North 56° 00' East, 277.22 feet along the southeasterly line of said Lot to the centerline of the Public Road Easement, 66 feet in width, as shown on a Record of Survey on file in Book 15, page 29 of Records of Survey, Records of Riverside County, California, and

the true point of beginning;
Thence North 340 00' West, 651.73 feet along said centerline to a point distant 10 feet southeasterly from

the northwesterly line of said Lot 14;
Thence North 55° 59' 30" East, 33 feet parallel with said northwesterly line to the most northerly corner of said Public Road Easement; Thence South 34 00'

00' East, 651.74 feet along the

northeasterly line of said Public Road Easement to said southeasterly line of Lot 14;

Thence South 56° 00' West, 33 feet along said southeasterly line to the true point of beginning. EXCEPTING the northwesterly rectangular 188.74 feet.

All of the above described parcel shall become and be known as SHELBY DRIVE EXCEPT the southeasterly 4 feet thereof lying within California Avenue.

BE IT FURTHER RESOLVED by the City Council of the City of Riverside, California, that pursuant to the recommendation of the Planning Commission of the City of Riverside a portion of said Lot 14, Block 7, in the City of Riverside described as follows:

Thence North 340 00' West, 145.00 feet along said 7 centerline; Thence South 56° 00' West, 33.00 feet; Thence South 34° 00' East, 145.00 feet to said 8 9 southeasterly line of Lot 14; Thence North 56 00' East, 33.00 feet to the true 10 point of beginning.
