second part, its successors and assigns, a perpetual easement and right-of-way for the
construction, reconstruction, inspection, maintenance, operation and repair of a
sanitary sewer, together with manholes, cleanouts, wye branches and other necessary
appurtenances, all hereinafter referred to collectively as "structure", in, under and
along that certain parcel of land situated in the County of Riverside, State of California,
described as follows:
That portion of the War of the NWar of Section 20, T2S, R4W, SBB&M, according to Official U. S. Government Survey thereof, described as follows: A strip of land 15.0 feet in width lying 7.5 feet each side of the following described center line: Commencing at a point in the easterly line of said War of the NWar of Section 20, said point being the most northerly corner of Lot 159 of University Highlands Unit No. 1, as shown on map on file in Book 31, pages 38 and 39, of Maps, Records of Riverside

County, California;
Thence NO 09'W. 23.03 feet along the westerly line of Lot
"C" (Highlander Drive) of said University Highlands Unit No. 1 to

the TRUE point of beginning;
Thence S89°39'58"W, 220.10 feet to a point in the northeasterly line of the right of way (100 feet wide) of the A.T. & S.F.
Railroad, last said point being the end of this described center
line.
