THAT for a valuable consideration, receipt whereof is hereby acknowledged, said parties of the first part do\_\_\_by these presents grant unto the said party of the second part, its successors and assigns, an easement and right of way for the construction, maintenance, operation, inspection, repair, replacement, and removal of electric lines and cables, including such additional lines as said grantee may from time to time in the future require, upon and by means of one line of poles, with supporting structures, crossarms, wires, anchors, fixtures, and appurtenances, for the transmission of electric energy for any and all purposes for which the same may be used, and communication purposes upon, over, and across that certain real property situated in the County of Riverside, State of California, described as follows:

A portion of Block 65 of Arlington Heights as shown on map on file in Book 11, Pages 20 and 21 of Maps, Records of San Bernardino County, California, being a strip of land 10 feet wide lying 5 feet each side of the following described centerline:

Commence at the most southerly corner of said Block 65; Thence N34°00'00"W, 180.00 feet parallel with the centerline

of Mary Street; Thence N56\*00'00"E, 4.00 feet, at right angles to last described course, to the TRUE point of beginning;
Thence continuing N56 00 00" E, 294.68 feet to an end in the

westerly line of the Gage Canal right of way.

The side line of said strip of land shall be lengthened or shortened as required to terminate northeasterly in said westerly

line of the Gage Canal right of way.

EXCEPT therefrom the portion lying within a 5 foot strip of land lying westerly of and contiguous with said westerly line of the Gage Canal right of way.


