NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the following described portion of SUNSET DRIVE

That portion of Sunset Drive as shown on map of Royal Hills Unit No.1 on file in Book 34, page 94 of Maps, Records of Riverside County, California, lying southwesterly of Alessandro Road as shown on said map and that portion of Sunset Drive shown as Central Avenue, lying southeasterly of the northeasterly prolongation of the northerly line of Sunset Drive as shown by Record of Survey on file in Book 23, page 63 of Records of Survey, Records of Riverside County, California,

be changed to ROYAL HILL DRIVE.
