RESOLUTION NO. 10357

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO.10346: RESERVING EASEMENTS AND RIGHTS OF WAY AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE RESERVATION OF SUCH EASEMENTS AND RIGHTS OF WAY; AND MAKING ITS ORDER VACATING A PORTION OF REPUBLIC STREET AND AN ADJOINING ALLEY.

WHEREAS on August 17,1965, the City Council of the City of Riverside adopted Resolution No. 10346 declaring its intention to order the vacation of a portion of Republic Street and an adjoining alley and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City
Council heard and considered the evidence offered by persons
interested and found and hereby finds from all of the evidence
submitted that the portion of Republic Street and an adjoining
alley ordered vacated are unnecessary for present or prospective
public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said portion of said street and alley in the City of Riverside, County of Riverside, State of California, described as follows:

Parcel 1:

That portion of Republic Street (50 feet wide)
lying northerly of the northerly line of Columbus
Avenue (60 feet wide) and southerly of the northerly
line of the right of way line of the Union Pacific
Railroad Spur, as said streets are shown by map of
