Thence East 334 feet to a point;
Thence North 46° 10' East,159.6 feet to a point;
Thence North 21° 43' East 145.5 feet to a point
240.5 feet east of the westerly line and 54 feet
south of the northerly line of Lot 168 of the Lands of the Southern California Colony Association, measured at right angles;


Thence North 29° East 24 feet to a manhole in Tequesquite Arroyo Sewer.
