GRANT OF EASEMENT (INDIVIDUAL)

614.6 THE GRANTORS THOMAS C. BORDEN and DORIS E. BORDEN hereby grant...... to SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, its successors and assigns, an easement and right of way to construct, use, maintain, alter, add to, repair, replace and/or remove, in, on, and over the real property hereinafter described, situated in the County of Riverside, State of California, an electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances, for conveying electric energy to be used for light, heat, power, telephone and/or other purposes.

Said real property is described as follows:

A strip of land, 10 feet in width, lying within the Southeast one-quarter of Section 34, Township 2 South, Range 6 West, S.B.B.&M., as shown by United States Government Survey, the centerline of said strip being described as follows; Commencing at a point in the centerline of Arlington Avenue, as conveyed to the County of Riverside by Deed recorded February 4,1925 in Book 629, page 55 of Deeds, records of said Riverside County, said point also being the Northeasterly corner of Twin Buttes Block, as recorded in Book 10, page 39 of Maps, records of said county; thence North 1 Degree 53 Minutes East a distance of 693.43 feet to the true point of beginning; thence South 88 Degrees 07 Minutes East a distance of 295 feet.

EXCEPTING THEREFROM any portions thereof lying within Mitchell Avenue as now established.

The Grantee, its successors and assigns, and its and their respective agents and employees, shall have the right to trim or top such trees as may endanger or interfere with said electric line, and shall have free access to said electric line and every part thereof, at all times, for the purpose of exercising the rights herein granted.
