RESOLUTION NO. 10713

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF ARLINGTON AVENUE TO KRONEN COURT.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside that the name of a portion of ARLINGTON AVENUE described as follows:

That portion of Arlington Avenue (80 feet wide) lying westerly of the westerly line of Hawarden Drive (20 feet wide) and easterly of the following described line:

Commencing at the northwesterly corner of Lot 5, Block 80 of Arlington Heights, as shown by map on file in Book 11, pages 20 and 21 of Maps, Records of San Bernardino County, California, said point being in the southerly line of Arlington Avenue;


Thence North 89° 31' East 507.28 feet along the southerly line of said Arlington Avenue to the true point of beginning, said point being the beginning of a tangent curve concave southwesterly having a radius of 755 feet and the initial radial line bears North 28° 34' 10" East;

Thence westerly along said curve through a central angle of 17° 36' 45" an arc distance of 232.08 feet to a point in the northerly line of Arlington Avenue and to the end of this line description;

The terminal radial line of said curve bears North 10° 57' 25" East;

be changed to KRONEN COURT.


