RESOLUTION NO. 10910

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES.

BE IT RESCLVED by the City Council of the City of Riverside:

That the herein described strip or parcel of land owned by the City of Riverside lying north of and adjacent to Fourteenth Street, be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes, to become and be a part of FOURTEENTH STREET.

: Thence continuing North 0° 03' West along the said westerly line 19.68 feet to the beginning of a non-tangent curve, concave northeasterly and having a radius of 450.00 feet, the initial radial line bears South 30° 50' 34" West;

Thence southeasterly along said non-tangent curve, through a central angle of 17° 28' 56", an arc distance of 137.30 feet to an intersection with a line that is parallel with and distant easterly 126.70 feet as measured at right angles to the said


