

RESOLUTION NO. 10965

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A SEWER EASEMENT OVER PORTIONS OF LOTS 14 AND 20 OF ROCKLEDGE PARK NO. 3.

WHEREAS it appears that the City of Riverside has a sewer easement over portions of Lots 14 and 20 of Rockledge Park No.3; and

WHEREAS it appears that said easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said sewer easement be and the same is hereby vacated, said easement being situated in the City of Riverside, County of Riverside, State of California, and described as follows:

A sewer easement over the easterly 5.00 feet of Lot 20 of Rockledge Park No.3, as shown by map filed in Book 21, page 1 of Maps, Records of Riverside County, California; together with the northerly 10.00 feet of the easterly 5.00 feet of Lot 14 of said Rockledge Park No.3;

RESERVING a public utility easement over the northerly 5.00 feet of Lot 14 and the southerly 5.00 feet of Lot 20.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.


