AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 11145; RESERVING PUBLIC UTILITY EASEMENTS AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE RESERVATION OF AND MAKING ITS ORDER VACATING SUCH EASEMENTS; A WALKWAY BETWEEN VIA SAN JOSE AND CANTERBURY ROAD.

WHEREAS on November 26, 1968, the City Council of the City of Riverside adopted Resolution No. 11145 declaring its intention to order vacation of a walkway between Via San Jose and Canterbury Road and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that the walkway ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, the City Council of the City of Riverside does ordain that the said walkway in the City of Riverside, County of Riverside, State of California, described as follows:

> All of Lot "H" of Canterbury Road Tract as shown by map on file in Book 26, pages 1 and 2 of Maps, records of Riverside County, California, together with all of Lot "E" of Sun-Air Homes No.2, as shown by map on file in Book 28, pages 65 and 66 of Maps, records of said County; RESERVING from said Lot "H" an easement over

the northeasterly 10.00 feet thereof for public

utility purposes;
ALSO RESERVING an easement for public utility purposes over all of said Lot "E";

be and the same is hereby, vacated.


