A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF DONNELLY DRIVE AND A PORTION OF CANYON CREST DRIVE.

WHEREAS on June 24, 1969, the City Council of the City of Riverside adopted Resolution No. 11281 declaring its intention to order the vacation of a portion of Donnelly Drive and a portion of Canyon Crest Drive and fixing the time and place of hearing all persons interested in the proposed vacations, pursuant to the provisions of the Street Vacation Act of 1941. being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds, from all of the evidence submitted that the portion of Donnelly Drive and the portion of Canyon Crest Drive hereinafter ordered vacated are unnecessary for present or prospective public use;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that said portions of said streets in the City of Riverside, County of Riverside, State of California, described as follows:

> Those portions of the West-half of the Northwest quarter of Section 32, Township 2 South, Range 4 West, San Bernardino Meridian, described as follows: Those portions of that certain strip of land 40.00 feet in width, conveyed to the County of Riverside for road purposes by deed recorded March 28, 1913, in Book 381 of Deeds, page 91 thereof, records of Riverside County, California, lying northerly and westerly of the following described line:
