RESOLUTION NO. 11322

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF CANYON CREST DRIVE.

WHEREAS on July 22, 1969, the City Council of the City of Riverside adopted Resolution No. 11302 declaring its intention to order the vacation of a portion of Canyon Crest Drive and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds from all of the evidence submitted

said portion of Canyon Crest Drive hereinafter ordered vacated is unnecessary for present or prospective public use;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the portion of Canyon Crest Drive in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Canyon Crest Drive (40.00 feet wide) in Section 31 and 32, Township 2 South, Range 4 West, San Bernardino Meridian, as conveyed to the County of Riverside by deed recorded June 18, 1917, in Book 433 of Deeds, at pages 300 and 302 thereof, records of Riverside County, California, lying southwesterly of the southerly line of Parcel 3 of Record of Survey on file in Book 45 thereof, at pages 93 and 94, records of said County, and lying northerly of the south line of said Section 31;

EXCEPTING THEREFROM that portion vacated by the City of Riverside by Resolution No. 10341 recorded August 18, 1965, as Instrument No. 95727, records of said County;

ALSO EXCEPTING THEREFROM that portion within that certain parcel conveyed to the City of Riverside by deed recorded in Book 3929, page 349, Official Records of said County;

ALSO EXCEPTING THEREFROM that certain parcel conveyed to the City of Riverside by deed recorded February 29, 1969, as Instrument No. 17505, Records of said County,




