Those certain streets within OLIVE HEIGHTS as shown by a map recorded in Book 5, Page 163, of Maps, Records of Riverside County, California, more particularly described as follows:

All of Lupine Street (40 feet in width), Iowa Avenue Extension (40 feet in width), and Olive Ridge Road (60 feet in width); the north 545.66 feet of Columbine Avenue; all that portion of Violet Street (60 feet in width) lying west of the south prolongation of the east line of Block 1; and all that portion of Lilac Street lying west of the south prolongation of the east line of Block 4 as shown by said Olive Heights,
