That portion of Lot 60 of the East Riverside Land Company's Subdivision of Section 19, Township 2 South, Range 4 West, San Bernardino Meridian, as shown by map on file in Book 6, Page 44 of Maps, records of San Bernardino County, California, more particularly described as follows:

Commencing at the south quarter corner of said Section 19; said corner also being the intersection of the centerline of Iowa Avenue with the centerline of University Avenue;
Thence North 0° 11' 02" East, along the centerline
of said lowa Avenue, a distance of 99.13 feet;

Thence west at right angles to the centerline of said Iowa Avenue, a distance of 55.00 feet to a point in the west line of said Iowa Avenue; said point also

being the TRUE POINT OF BEGINNING;
Thence South 80° 17' 30" West, a distance of 199.65 feet to a point in the north line of University Avenue; Thence South 89° 52' 00" East, along the north line of said University Avenue, a distance of 189.67
