FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, HANS KIRSCHSIEPER and ANNEMARIE KIRSCHSIEPER, husband and wife, as joint tenants as to a 40% interest, BURDETTE M. KAROS, an unmarried woman as to a 40% interest, and SUSAN COLLINS VRANISH, a married woman as to a 20% interest

as Grantors, grant(s) to the CITY OF RIVERSIDE, a municipal corporation of the State of California, as Grantee, its successors and assigns, a temporary easement and right-of-way for the construction and installation of roadway facilities

together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of the Northeasterly 40.00 feet of Lot "P" of TRACT NO. 2 of LA SIERRA HEIGHTS, as shown by map on file in Book 7, page 66 of Maps, Records of Riverside County, California, as vacated by the County of Riverside by "Order of Vacation" recorded January 22, 1930 in Book 837 of Deeds, page 423 et seq., records of said Riverside County, described as follows:

COMMENCING at the intersection of the centerline of LA SIERRA AVENUE (formerly Holden Avenue) with the centerline of BUSHNELL AVENUE (Lot ZZ) as said streets are shown by LA SIERRA GARDENS, on file in Book 11 of Maps, at pages 42 thru 50, inclusive thereof, records of said Riverside County;

THENCE N 44° 14' 40" E (recorded N 44° 15' E), along said centerline of Bushnell Avenue, 71.30 feet;

THENCE N 45° 45' 20" W, 20.00 feet to a point in the Northwesterly line of said Bushnell Avenue;

Said temporary construction easement is to be used for all purposes proper and convenient in the construction and installation of roadway facilities, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

Upon completion of construction, the City of Riverside shall remove all debris, waste or excess material, brush or other matter or material deposited or placed upon the land, and with the exception of vegetation, return the surface as near as possible to its condition before construction.

This construction Easement shall terminate upon completion of the work of constructing the roadway facilities or within one year of the date of recording this document, whichever occurs first.


