

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Lot 9 of Block 31 of the Lands of the Riverside Land and Irrigating Company as shown by map on file in Book 1, Page 70 of Maps, Records of San Bernardino County, California, described as follows:

Commencing at the intersection of the northeasterly line of said Lot 9 with the southeasterly boundary of the Atchison, Topeka and Santa Fe Railway Company property right of way, said property being 100.00 feet in width;
