A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACTS NOS. 6763-1 AND 6763-2 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 6763) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF LYON AVENUE, CLARKSDALE DRIVE, BLUERIDGE DRIVE AND MORRISTOWN DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Lyon Avenue, Clarksdale Drive, Blueridge Drive and Morristown Drive:

Parcel 1

Lot G and Lot F (1-foot barrier strips) of Tract No. 6763-1, as shown by map on file in Book 87 of Maps, at page 42 through 45 inclusive thereof, Records of Riverside County, California.

Parcel 2

Lot H and Lot I (1-foot barrier strips) of Tract No. 6763-2, as shown by map on file in Book 90 of Maps, at pages 70 through 72, inclusive thereof, Records of Riverside County, California.
