

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 7 in Block 65 of Tract No. 2 of LA SIERRA HEIGHTS, on file in Book 7 of Maps, at Page 66 thereof, records of said Riverside County, more particularly described as follows:

BEGINNING at a point in the northeasterly line of said Lot, North 23° 13' 30" West 150 feet from the most easterly corner of said Lot; said point being also the most northerly corner of that certain parcel of land conveyed to William F. Scheffel, et ux., by deed recorded December 19, 1945, as Instrument No. 2265 of Official Records of said Riverside County;

THENCE South 65° 00' 15" West along the northwesterly line of said parcel 10.01 feet to a line which is parallel with and distant 10.00 feet southwesterly, as measured at right angle, from said northeasterly line of Lot 7;

THENCE North 23° 13' 30" West along said parallel line 22.09 feat to the southeasterly line of that certain parcel of land conveyed to Douglas Alfred Bailey, et ux., by deed recorded October 28, 1952, as Instrument No. 45916 of Official Records of said Riverside County;

THENCE North 65° 32' 00" East along said southeasterly line 10.01 feet to said northeasterly line of Lot 7;

THENCE South 23° 13' 30" East along said northeasterly line 22 feet to the point of beginning.
