BE IT RESOLVED by the City Council of the City of Riverside, California, that the hereinafter described strip or parcel of land owned by the City of Riverside, being a portion of the city's Municipal Airport property, be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes to become and be known as a portion of Hillside Avenue. Said parcel or strip of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

All that portion of the SW 1/4 of Section 32, T. 2 S., R. 5 W., San Bernardino Meridian, lying easterly of the following described line:

BEGINNING at a point in the northerly line of Lot 17 of View Park Tract Unit No. 1, on file in Book 39 of Maps, at Page 56 thereof, records of Riverside County, California, distant North 76° 52' 17" West 7.72 feet from the most easterly corner of said Lot 17;

THENCE North 52° 22' 51" East, 22.86 feet to the beginning of a tangent curve with a radius of 467.00 feet and concaving northwesterly;

THENCE Northeasterly along said curve an arc length of 366.16 feet, thru a central angel of 44° 55' 24" to the end thereof;

THENCE North 7° 27' 27" East, 129.39 feet to the beginning of a tangent curve with a radius of 533.00 feet and concaving easterly;

THENCE Northerly along said curve an arc length of 150.27 feet, thru a central angle of 16° 09' 13" to the end thereof;

THENCE North 23° 36' 40" East, 0.66 feet to the westerly line of Hillside Avenue (66 feet wide) and to the end of this line description.


