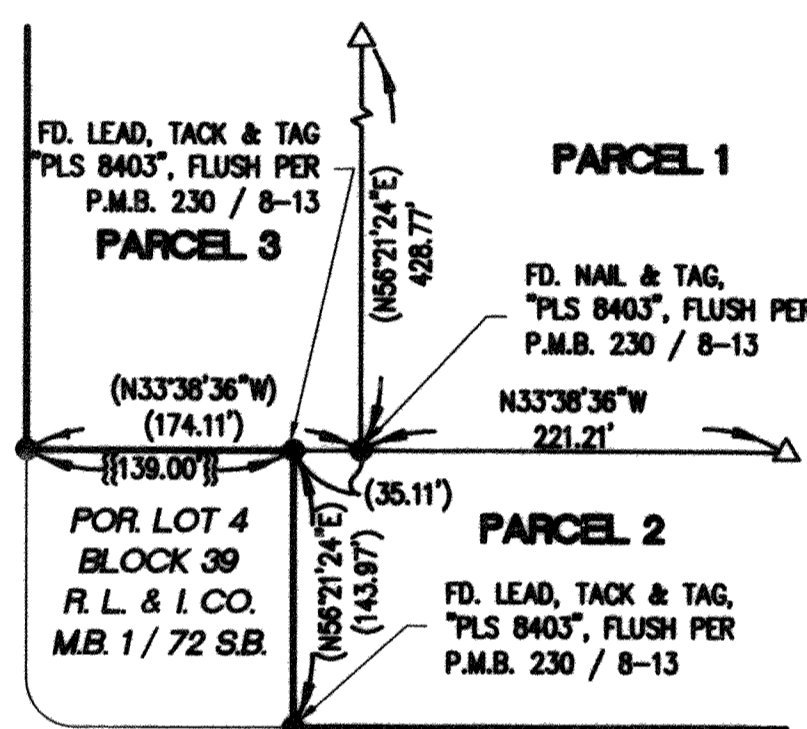
DETAIL A
NOT TO SCALE



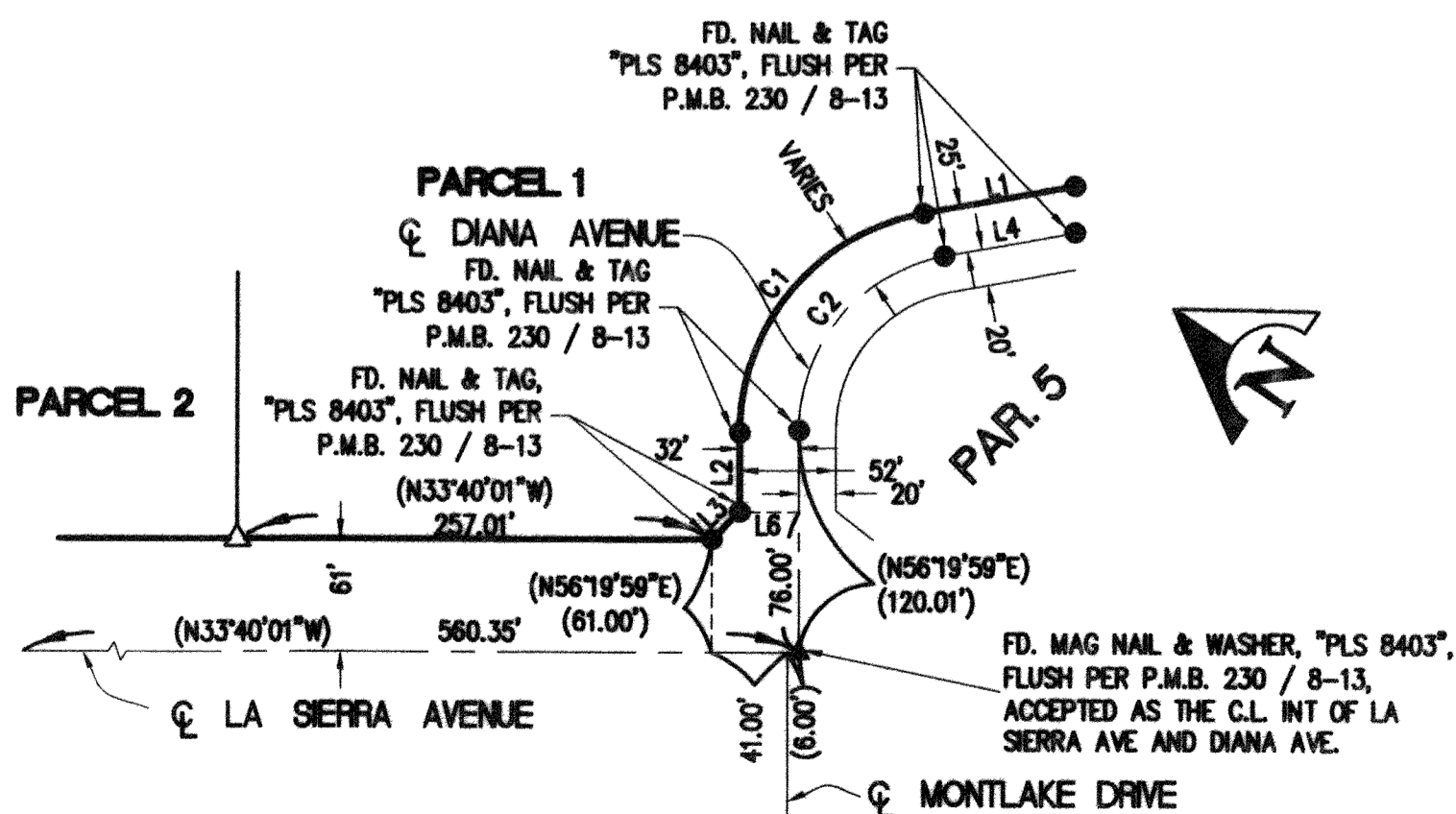
