

1 RESOLUTION NO. 24053

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING THE CITY'S MASTER FEES AND
4 CHARGES SCHEDULE IN RESOLUTION NO. 21960, AS AMENDED,
5 ESTABLISHING THE COMMERCIAL CANNABIS SALES PERMIT FEE.

6 WHEREAS, the City has the authority to impose fees pursuant to its authority under Article
7 XI, §7 of the California Constitution and under its complementary powers under Section 37112 of the
8 California Government Code and Section 200 of the Riverside City Charter; and

9 WHEREAS, the City has established a policy of recovering the full costs reasonably borne as
10 a result of providing special services of a voluntary and limited nature, such that general taxes are not
11 diverted from general services of a broad nature and thereby utilized to subsidize unfairly and
12 inequitably such special services; and

13 WHEREAS, in Chapter 3.30 of the Riverside Municipal Code, the City Council established its
14 policy as to the recovery of costs and more particularly the percentage of costs reasonably borne to be
15 recovered from users of City services and directing staff as to the methodology for implementing said
16 Chapter 3.30; and

17 WHEREAS, the adoption of a schedule of fees and charges to be paid by those requesting such
18 special services and the percentage of costs reasonably borne by those persons receiving such special
19 services are necessary so that the City might effectuate its policies; and

20 WHEREAS, the City desires to provide for the establishment of the new fee for the
21 Commercial Cannabis Sales Permit Fee, which shall consist of the evaluation and review of
22 applications fee and the site review fee; and

23 WHEREAS, the City Council held a duly noticed public hearing on October 24, 2023, and has
24 considered all oral and written evidence presented regarding the revision to the Master Fees and
25 Charges Schedule; and

26 WHEREAS, all requirements of law regarding the notice and the provision of data are hereby
27 found to have been met; and


