On Tuesday 10/31/17 at approximately 1130 Hrs. I received a phone call reference a SWAT call-out regarding a barricaded subject with a hostage at Castle View Elementary School, located at 6201 Shaker Riverside Ca. During the call, I was informed that a black male adult had entered the school and taken a teacher hostage inside her classroom.

Narrative:

I arrived at the scene shortly after receiving the initial call. Upon my arrival, I entered the school grounds via the south east side of the school play yard, where I met up with a perimeter unit. I was informed by him that the ARV was around the corner and he told me that he would take me to it. I got into the Officers unit and he took me to the north west portion of the campus where I met up with SWAT personnel. Once all RED Team SWAT personnel were accounted for, we entered the ARV and were taken to class room A1, which is where the suspect was believed to be barricade in. Once we arrived, the ARV driver stopped the vehicle directly in front of the classroom and we became ERT-1.

I remained with ERT-1 at the ARV until the decision was made that a crisis entry was going to be executed. When the entry was made I moved from the rear of the ARV to the front and stood by in case my Police Service Dog was needed by the entry teams. I never made entry into the classroom. I stood by until the situation was stabilized.

Once the incident was over, I was instructed to go to the Magnolia Police Station. I remained at the station until I was cleared at approximately 2100 Hrs. by Sgt. McCoy.
