Incident Number: On 02-20-17, at 2253 Hours, I responded to the area of MacArthur and Hawthorne reference "shots fired" with officers involved in the incident. Upon arrival, I was assigned a perimeter post at Jackson Street and Garfield Street. I held that position and on 02-21-17, at around 0230 hours, I was assigned to speak with residents from [REDACTED] at the intersection of Sage Ave. / Mac Arthur Rd. I spoke with O1/[REDACTED] O1 told me he was asleep most of the night and never heard any gun shots around the time of the incident (2253 hours). O1 told me S1 was the boyfriend at the house and S1 was last seen inside the residence. O1 had no further information. I then spoke with O2/[REDACTED]. O2/[REDACTED] d he was asleep in the garage of the residence and normally is a transient with no official address. O2/[REDACTED] stated he never heard gunshots and was sleeping at the time of the incident. O2/[REDACTED] had no further information. No further information.
