On Tuesday February 21, 2017 at approximately 0000 Hrs. I received a call from RPD Dispatch regarding a METRO / SWAT callout in the area of Garfield and MacArthur Rd. Riverside Ca. The information provided to me was that there was a suspect somewhere in the area who was involved in a shooting with police.

Narrative:

Upon my arrival, assisting METRO / SWAT and I were provided with an initial brief by Sgt. D. Corbett. During that brief, I was informed that officers attempted to contact a subject on MacArthur, but the subject fled and at some point opened fire on the officers. Officers returned fire and it was believed the suspect was hit by the gun fire, but the officers lost sight of the suspect. One yard was searched by patrol officers, where they located a blood trail leading up to [REDACTED]

A team was established, which included myself, and we were taken to Sage Ave by the Armored Rescue Vehicle. Once on Sage, the team I was assigned was tasked with evacuating the residence just west the primary residence. The west residence shared the same driveway as [REDACTED] and was approximately 30 yards to the west. Several occupants were contacted and evacuated from that west residence. They were taken to a safe location while other members of the METRO / SWAT Team were dealing with evacuating the occupants of the primary location. Once they were evacuated, updated information was given that the suspect was barricaded inside the target home with a gun. At this point, Officer Smith, Officer Macias, and I took a cover position inside the residence directly to the west of the target location. I remained inside the residence, until the mission was concluded.
