Narrative:

On February 20, 2017, at about 2254 hours, I heard Officer Carmona and Officer Espinoza say on the radio they were involved in a shooting at 4041 Macarthur Rd. and the suspect was last seen running northeast from their location. I immediately responded from the far west end of the city.

Upon arrival, I learned the suspect was armed with a handgun and had shot at the officers. Several officers were on scene and there was a female lying prone in the middle of the street. We detained her and then coordinated taking two people out of a Kia and detained them. Other officers watched those people.

I was put on a search team to only make the immediate surrounding area safe and lock down the immediate crime scene. We searched towards the last know direction of the suspect and immediately found blood on the ground, a cell phone and a hat. At that time, other officers said they found a blood trail on Sage Ave. so we decided not to search any further and hold what we had cleared.

A SWAT callout was started and I was assigned to an emergency response team to cover Saffron Ct. Information developed that the suspect was inside [REDACTED] so to contain the house I took a position in the southeast part of [REDACTED] and could see parts of the north and east side of the main residence of [REDACTED]

Many efforts were made to call the suspect out of the house but he refused. CS gas was deployed by other team members of the SWAT team on the east side of the house. Several moments after the CS gas was put into the house a sheet inside the window that was originally close to a lamp started to catch on fire. Once the sheet was on fire it quickly caught the exterior partitioned area of the house on fire. About two minutes after the fire started there was smoke traveling into the house and I heard a gunshot come from the north side of the house near the middle.

The Fire Department came and gave us a fire hose to try and put the fire out. We continuously put water on the house until the Fire Department came back to us when it was safe to do so and they took control of the fire hose.
