On 02/21/17 around 0230 hours, I began to receive several calls and text regarding an ENT call out. I was advised that a male subject who had attempted to murder a police officer had barricaded himself in a residence on Sage Ave. at McArthur. I responded to the scene and took on the supervision responsibility for the ENT team. Upon my arrival, I was briefed by Sgt. McCoy who was one of the two on scene supervisors for the METRO Team. I was asked to have the throw phone ready for deployment in order to establish some sort of communication with the barricaded suspect. At approx. 0549 hrs., the throw phone was deployed by the METRO team. Several attempts to establish communication with the suspect failed since no one answered the calls being made on the throw phone. Those attempts stopped after other tactical measures were taken by the METRO Team. Eventually the residence caught fire and the ENT team was now used as perimeter security. I then assumed the role of the investigation supervisor and oversaw the investigation being conducted by the CIB Persons Unit Detectives. I cleared the scene at approx 1745 hours.
