8 heard five shots, a short pause (maybe for a few seconds), and then seven more shots. She said
9 she thought that maybe they (her family) should call the cops. She went outside to the front of her
10 house and saw the cops looking at her Dad's [REDACTED] She thought that maybe her Dad's [REDACTED] had
11 been shot at. The police told her to stay inside. She did not see the actual shooting, she only
12 heard it.

14 I attempted to contact someone at [REDACTED] but there was no answer and the
15 property appeared vacant. I also attempted to contact someone at [REDACTED] but
16 there was no answer at the door. These were the only three addresses that I checked during the
17 canvass.
