Narrative of Supplemental Report:

On 02/22/17 at approximately 0700 hours, I was requested by Detective Rick Cobb to respond to the Riverside County Coroner-Morgue to attend and document the autopsy for S/ GARCIA, Marcelino, Arthur DOB 04/13/77. I arrived at the location at approximately 0850 hours and met with Det. Rick Wheeler. I began taking my photos at approximately 0914 hours. I received evidence items A-01 - A-08 from Forensic Tech E. Arballo N4199 (see attached Property Report for full item descriptions). I finished my assignment and left the location at approximately 1125 hours. I returned to the Magnolia Station and placed all evidence items into the evidence vault at approximately 1200 hours.

On 02/23/17 at approximately 0715 hours, I downloaded (127) digital photographs into a secure file format (see attached Photo Logs).

On 02/28/17 at approximately 0820 hours, I retrieved all evidence items from the evidence vault for processing. I placed evidence items A-01 - A-06 into the Magnolia Station outside bio-lockers #3, and released evidence items A-07 and A-08 to Police Property Specialist R. Anzelde at approximately 1058 hours.

No further action was taken.
