1 On Friday, July 20, 2018, at approximately 1946 hours, I was working uniformed patrol for the City of
2 Riverside when Dispatch broadcasted information that Riverside County Sheriff's Officers were involved
3 in a vehicle pursuit heading northbound on the 215 freeway near Van Buren Blvd. As Riverside County
4 Sheriff's were pursuing the vehicle, it was broadcasted that the driver of the vehicle had fired shots at the
5 officers.

7 The pursuit ended on Arlington Ave near the intersection of California Ave. After arriving on scene I
8 maintained a crime scene perimeter spot. I was positioned with my unit on Arlington Ave, east of where
9 the incident occurred, blocking the east side of the crime scene near the east entrances to the shopping
10 center to the south, and the Sears parking lot to the north.

12 I maintained my perimeter spot until I was relieved and notified to leave the scene.
