On 07-20-18, partner Officer Morgan and I were working uniformed patrol in a marked patrol unit in the City and County of Riverside. At about 1946 hours, dispatch advised Hemet PD was in pursuit of a vehicle heading northbound on the 215 Frwy. and the suspect was shooting at the pursuing officers. Dispatch captured the suspect vehicle exited Van Buren Blvd. and was traveling west through the City of Riverside. Due to the seriousness of the crime and the potential for harm toward officers and civilians, I activated my patrol units lights and siren at Van Buren Blvd. and Wells Ave. at 1954 hours. I joined the pursuit in the area of Van Buren Blvd. and the 91 freeway. The pursuit ultimately ended at Arlington Ave. and Streeter Ave. I assisted by moving civilians away from the area of the suspect vehicle. I took a perimeter position in the Bank of America parking lot located at [Redacted] From this position, I assisted with crowd control and applying crime scene tape to establish a perimeter.
