DETAILS:

13 On Thursday, March 8, 2018, I assisted Central Homicide Unit (CHU) Inv. Johnson with an Officer Involved
14 Shooting incident that occurred at 9931 Willowbrook Rd., Jurupa Valley, CA. My assignment was to manage
15 the charting of the Riverside Police Department officers involved with the shooting. This report reflects the
16 charting of RPD Officer Sancho Lopez.
17

18 The charting of Officer Lopez took place in the Community Room within the lobby of the Jurupa Valley
19 Sheriff's Station. Present for the charting was Riverside County Sheriff's Forensic Technician Jane Muschell,
20 who photographed process.
21

22 The charting process started at 12:22AM. Forensic Technician Muschell photographed Officer Lopez's
23 clothing to memorialize the condition of his uniform at the time of the shooting. He wore (from head to toe)
24 a black t-shirt under a black load bearing (LBV) vest with various pouches sown onto it. The vest had a cloth
25 RPD badge sown on the left chest, a Riverside Police Metro Team patch on the right chest. The back of the
26 LBV had a display patch that read POLICE adhered to it. He wore a black nylon uniform belt with two dual
27 magazine pouches, a dump pouch, two handcuff pouches, a thigh holster with two leg straps. He wore green
28 BDU pants and black boots.
29

30 At the time of the charting, Officer Lopez's uniform belt was photographed on a sheet of butcher paper. The
31 belt contained (from right to left) a two magazine pouch with two steel Mec-Gar 8-round handgun magazines
32 inserted in it, a black nylon dump pouch folded up, two handcuff pouches with handcuffs, a handgun holster
33 with two thigh straps for a Springfield Armory 1911, .45 caliber, semi-automatic pistol (s/n: NM490098), with
34 a mounted Surefire X-300 Ultra flashlight, and a two magazine pouch with two steel Mec-Gar 8-round handgun
35 magazines.
36

37 The firearm was loaded with one live round in the chamber, and loaded with eight live rounds in an 8-round
38 Wilson Combat steel handgun magazine. Each of the four magazines in the magazine pouch contained eight
39 live rounds. Forty-one rounds were accounted for on the duty belt. Each of the rounds had a head stamp that
40 read WINCHESTER 45 AUTO. Officer Pap explained he did not fire his handgun, and he loads his magazines
41 to capacity.
42

43 Next, Officer Lopez's LVB was charted. It was removed and placed on a sheet of white butcher paper. The
44 contents of the vest were exposed and recorded. The vest housed a handheld radio and microphone, and a
45 flashlight.

47 The charting process revealed Officer Lopez carried forty-one rounds on his duty belt. All of Officer Lopez's
48 rounds are accounted for.

1 The charting process ended at 12:38AM. Then, Officer Lopez left the room. A short time later, he met with
2 Inv. Johnson and an interview was conducted.¹ The charting process continued with the charting of Officer
3 Robert Monreal.²

4
5 This is an open investigation and this report's status reflects such. A copy of this report was incorporated into
6 the investigation file managed by Investigator Johnson.
